Accountancy and professional services firms are one way to train for the ACA. You can also train in large companies, small enterprises, charities and government bodies, among others. Each employer has their own entry criteria, so make sure you check this before you apply.

WHAT IF YOUR CHOSEN EMPLOYER ISN'T AUTHORISED BY ICAEW?

If you want train for the ACA, we're here to support you. Provided the employer meets our training standards, the process for them to become authorised to train you is simple, free of charge, and can take as little as three weeks.

What is the training and exam schedule?

There are four integrated elements to ACA training. With an emphasis on professional development and nurturing skills, the qualification covers far more than technical accountancy. It's designed to develop leadership potential, and its content is reviewed annually to ensure you're kept informed about the latest developments in finance, accounting and business.

01

ETHICS AND PROFESSIONAL SCEPTICISM

Ethics and professional scepticism are an essential part of being a chartered accountant. You'll follow a structured programme to ensure you know how to apply them - focusing on areas such as integrity, objectivity and independence.

PRACTICAL WORK EXPERIENCE

You need to record 450 days of relevant 'on-the-job' work experience during your period of approved training. If you have completed an internship or placement year with one of our authorised employers, you may be able to count up to 12 months' experience towards your ACA training.

02

PROFESSIONAL DEVELOPMENT

Demonstrate your competence in seven key professional skills (such as communication, teamworking and decision-making) by providing examples from your work experience.

04

ACCOUNTANCY, FINANCE AND BUSINESS MODULES

There are 15 modules, each with its own exam. These modules are staged across three levels: the first introduces you to core concepts; the latter two build on your growing technical knowledge and experience.

ACA training

The ACA equips you with in-depth knowledge across a range of topics in accountancy, finance and business. The 15 computer-based exams are designed to complement the practical experience you will gain, so you can put your knowledge into practice. The exams are split across three levels:

CERTIFICATE LEVEL

Introduces you to the fundamentals of accountancy, finance and business. Once completed, this is a standalone qualification known as the ICAEW Certificate in Finance, Accounting and Business (ICAEW CFAB).

ICAEW CFAB also serves as a stepping stone to the ICAEW Business and Finance Professional (BFP) designation. Once you have completed ICAEW CFAB, you only need to complete the ICAEW Ethics Learning Programme and gain 12 months' work experience within a business and finance role to apply for the designation and use the BFP letters after your name. PROFESSIONAL LEVEL

Builds on the fundamentals and tests your ability to use technical knowledge in real-life scenarios.

ADVANCED LEVEL

Exam schedule

It is possible to start the ACA on your own as an independent student. However, you'll still need to secure a training agreement to acquire the necessary practical work experience. Your employer will guide you on the pace and order that you complete the modules, except for the Case Study, which you have to take last. 90% of ACA students complete their training and exams in four years or less.

The exam schedule varies across the levels:

CERTIFICATE LEVEL

Certificate Level exams can be taken in any order, but you must pass every exam, or receive credit for prior learning to complete this level. Each exam

PROFESSIONAL LEVEL

These exams are available to sit every March, June, September and December. Each exam is 2.5-3 hours long

ADVANCED LEVEL: CORPORATE REPORTING AND STRATEGIC BUSINESS MANAGEMENT

These can be taken in July and November each year.

Each exam is 3.5 hours long

ADVANCED LEVEL: CASE STUDY

This is your final exam which you will attempt in the final year of your training agreement, once you have taken, or received credit for all other exams.

What are the entry requirements?

- To start ICAEW CFAB you don't need any other qualifications, just a real interest in business.
- If you haven't completed ICAEW CFAB or the Level 4 apprenticeship and you want to start the ACA, you'll need to have two A-level passes (grades A*-E) or equivalent. You'll also need three GCSE passes (grades 9-4/A-C) or equivalent.
- Before applying to an employer, check their entry requirements. GCSE, UCAS points and degree result requirements vary.
- Employers welcome all degrees. If you have completed a degree that is not directly related to accountancy, you can still utilise the knowledge and skills you have developed in your future career.

Recognition for prior knowledge and experience

You may be eligible for credit on some exams if you've studied accounting, finance or business at university. Also, if you've worked for one of our authorised employers on an internship or placement, within the last two years, you may be entitled to claim credit for prior work experience for up to eight months.


MOVE WITH THE BIG CHANGES

As well as giving you time away from work to study, employers will usually pay for your tuition with a dedicated provider and also pay for your exam and student registration fees. You'll need to successfully complete the ACA qualification before you can apply to become a member of ICAEW.


